# Program description

- Sustainable development is an important objective of contemporary world economic development.
- UN agreement of 2015 made Sustainable Development Goals (SDGs) the official part of strategic planning for all countries, which signed the Agreement
- We foresee the enlargement of the university programs concentrated around SDGs. → In this respect, the suggested program may become a pioneer in Russia, attracting Russian and Foreign students.
- Brazil, Russia, India, China and South Africa are the large-scale economies, the ways of their economic growth are rather extensive than intensive. → This program will help the students from BRICS-countries acquire practical knowledge in rational using of land, water, labor, energy, food, transport, technology, cultural heritage etc.
- The program is aimed at teaching the students to use the interdisciplinary methods of scientific cognition in the areas of economics, international relations, political sciences, history, sociology and culture.

# Program structure - 1

The Master of Sustainable Development consists of the following elements:

- Core courses 42 ECTS credits total

Core courses form the foundation of skills and knowledge in the key areas of world economy, economics and international affairs. Core courses are obligatory and students take the core courses in their first year of study.

- Elective courses 20 ECTS credits total

Elective courses allow students to customize their education to suit their own interests and career goals. Students take a total of five elective courses: one in the second semester and four in the third semester. Through elective courses students build the unique expertise and marketable skills in the areas of their choice.

- Adaptation courses (Additional Program component): 6 ECTS credits total

For students who do not have a substantial background in global economy and international affairs the Program offers adaptation courses aimed at building a solid base for further more in-depth knowledge of specific subjects.



# Program structure - 2

- Optional courses (Additional Program component): 3 ECTS credits  
Students may choose to take an optional course as an additional component to their curriculum.
- Research Seminar: 16 ECTS credits (4 semesters)  
In order to gain analytical and research skills students attend a scientific and research seminar. A large part of the seminar is dedicated to the term paper and thesis preparation guidelines.
- Term paper (year 1): 6 ECTS credits
- Internship (8 weeks in the 4th semester): 12 ECTS credits
- Master Thesis: 24 ECTS credits
